# MUTUAL AID IN MOTION: LINEWORKERS SUPPORT HURRICANE RECOVERY

Four dedicated lineworkers from Meeker Cooperative recently returned from an extended mutual aid mission to assist with hurricane recovery efforts in the Southeast following the devastation caused by Hurricanes Helene and Milton.

The team, in collaboration with Stearns Electric, initially deployed to South Carolina but extended their mission to aid in Florida, demonstrating an unwavering commitment to support communities severely impacted by both storms. Their tireless efforts helped restore power and bring a sense of normalcy back to the region.

Luke Johnson, CEO/General Manager of Meeker Cooperative, and Electric Operations Manager Dan Schrupp led the decision to deploy the team, emphasizing the Cooperative's commitment to Cooperative Principle #6, "Cooperation Among Cooperatives." Schrupp noted, "We have a strong tradition of helping communities in need. When a storm hits elsewhere, we support recovery efforts knowing that others would assist us in our time of need."

# HURRICANE STORY CONTINUED...

The Meeker team—John Grabow, Underground Foreman; Logan Josephson, Overhead Foreman; Brandon Skalberg, Journey Lineworker; and Nate Glimsdal, Journey Lineworker—departed on October 2, 2024, to assist at Blue Ridge Electric Cooperative in Pickens, South Carolina, one of the hardest-hit areas. They worked on replacing broken poles and reinstalling conductor lines, helping to restore power to nearly 66,000 homes out of Blue Ridge's 71,000 members in the wake of Hurricane Helene's widespread damage.

Josephson reflected on the challenges of working in South Carolina's rural terrain, with narrow, winding roads and limited access. "There wasn't a straight road to be found. Everything was hilly, which made it hard to move our equipment," he explained. Despite these obstacles, the team made significant progress in restoring infrastructure.

Upon completion of their work in South Carolina, the team prepared to head home. However, as Hurricane Milton ravaged Florida, leaving 3 million people without power, Meeker Cooperative's lineworkers quickly shifted plans and headed directly to Peace River Electric Cooperative in Wauchula, Florida. Arriving just as the storm approached, they rode out the hurricane positioning themselves to respond immediately once conditions allowed. 29-06-201 As one of the first out-of-state crews on the scene, their work involved replacing numerous poles, reconnecting downed conductors, and navigating widespread damage amidst fallen trees and debris.

The extreme conditions in Florida required different approaches. "In Florida, the heat and humidity added another layer of difficulty, and nearly all the poles we worked with were concrete," said Skalberg. Despite these challenges, the team worked seamlessly alongside over 1,000 linemen from across the U.S. and Canada.

On October 15, after nearly two weeks of intense recovery efforts across two states, the team returned home to Minnesota. The lineworkers noted the warm reception they received from local residents, many of whom expressed gratitude for their swift action. "Helping a community recover, especially under such challenging conditions, is deeply meaningful for all of us," said Grabow.

Meeker Cooperative is proud to have assisted in this mutual aid effort and will be ready to support recovery efforts whenever communities need it most in the future.

# BASIN EPC \$1,000 COLLEGE SCHOLARSHIP AVAILABLE FOR DEPENDENTS OF COOPERATIVE MEMBERS & VIBRANT CUSTOMERS

Meeker Cooperative is pleased to make available a \$1,000.00 college scholarship funded by Basin Electric Power Cooperative, one of Meeker's power suppliers.

To be eligible a student must:

- be a dependent child (including adopted or step-children) of a Meeker Cooperative member or Vibrant subscriber; be enrolled or planning to enroll in a full-time undergraduate course of study at an accredited, two-year, or four-year college, university or vocational/technical school; enter college in the fall of the same year the scholarship is given;
- not have previously received this award;
- be a US citizen: and
- complete and submit all required materials and the scholarship application form by the application deadline.

Completed applications must reach Meeker Cooperative by close of business on Friday, January 31, 2025. The application is available on Meeker's website under Member Services (www.meeker.coop/download-forms). The form may be completed online, but must be printed to submit with the supporting materials. Applications are also available at the Cooperative by calling Mary Alice Holm at 320-693-3231.

All decisions by the Scholarship Selection Committee will be final.

#### HONEY BOURBON CRANBERRY SAUCE | SUBMITTED BY: MICHELE BOREEN



#### **INGREDIENTS**

- 4 cups (1 12-ounce bag) fresh cranberries, rinsed
- 1/3 cup brown sugar
- 1/3 cup honey
- 1/3 cup bourbon
- 2 sprigs fresh rosemary

- 1/2 teaspoon ground cloves
- 1 cinnamon stick
- Zest of 1 orange
- Juice of 1/2 orange
- A pinch of salt and freshly ground pepper

#### **DIRECTIONS**

Combine all the ingredients in a pot, over medium heat. Once boiling, lower the heat and simmer until the cranberries burst, about 10 minutes. Continue cooking until the desired thickness. The sauce will thicken further as it cools! Remove from heat and taste to see if it's too tart. If yes, you can adjust by adding more honey to taste. Remove the rosemary sprigs and cinnamon stick, and let it cool completely. Then, transfer to an airtight container and refrigerate for at least 2 hours or up to a week! Serve chilled, reheated or at room temperature.

# APPLICATIONS AVAILABLE FOR CO-OP BOARD OF DIRECTOR CANDIDATES IN DISTRICTS 3, 5 AND 8

Meeker Cooperative is member-owned and governed by local leadership. Your Cooperative's Board of Directors is made up of nine Cooperative Members elected to serve from throughout the nine districts which make up the Cooperative's service territory. Directors are elected by you, the Member-Owners.

At the 2025 Annual meeting, which will be held at Meeker's headquarters at noon on May 21, 2025, the director seats in Districts 3, 5 and 8 are up for election following the normal rotation of districts for election.

These districts are made up of the following townships:

**District 3:** Luxemburg, Maine Prairie, South Maine Prairie in Stearns; Forest Prairie in Meeker

**District 5:** Fairhaven in Stearns, Cokato, Southside, French Lake in Wright, Dassel in Meeker

District 8: Darwin, Ellsworth in Meeker

Members in these districts that are interested in being placed on the ballot, and meet the qualifications identified in the bylaws, must submit a completed Meeker Cooperative Application for Director Form by the close of business on January 21, 2025.

The process for director elections is outlined in the bylaws of the Cooperative.

All potential candidates must declare their intention to be placed on the ballot by submitting a completed Application Form and be declared qualified for placement on the ballot by the Qualifications and Election Committee (Q&E Committee). No write-in candidates shall be deemed valid.

The bylaws direct the Board of Directors to appoint a Qualifications and Election (Q&E) Committee consisting of one Member from each of the Director Districts which is not up for election. It shall be the responsibility of the Q&E Committee to review all of the applications submitted and to determine that all candidates meet the stated qualifications.

The Committee will notify any potential candidate that does not meet the qualifications and allow seven days for the candidate to comply with said requirements. The decisions of the Q&E Committee will be final.

The Committee will have the authority to place qualified candidates on the ballot for election, and for any district in which there is only one candidate, waive the ballot process and declare the candidate elected.

The Qualifications and Election Committee shall prepare and post at the principal office of the Cooperative at least 75 days before the meeting the list of qualified candidates for director elections. 29-13-402 If no Member from a district up for election is placed on the ballot, said position shall be deemed vacant following the annual meeting and the Board of Directors may appoint a Member from said district to fill said position until the next annual meeting and election of directors.
